SCHEDULE "A"

MIDDLESEX CONDOMINIUM CORPORATION NO. 83

BY-LAW NO. 8

BE IT ENACTED as a By-Law of Middlesex Condominium Corporation No. 83 (hereinafter referred to as the "Corporation") as follows:

1.1 The Directors of the Corporation are hereby authorized:

- (a) to commit to borrow, and to borrow, up to the sum of ONE HUNDRED EIGHTY THOUSAND DOLLARS (\$180,000) from the Toronto Dominion Bank for the purpose of financing the renovation and repair of the condominium parking deck and underlying parking garage structure, such loan to be at the current rate of interest offered by the Toronto Dominion Bank and to be repayable over a term of up to a maximum of 5 years
- (b) in connection with such loan to charge, mortgage, hypothecate, pledge or otherwise create a security interest in all or any of the currently owned or subsequently acquired real or personal, moveable or immovable property of the Corporation, including, without limitation, book debts, rights, powers, franchises and undertakings to secure any present or future indebtedness, liabilities or other obligations of the Corporation; and
- (c) to delegate to such one or more of the Officers and Directors of the Corporation as may be designated by the Directors, all or any of the powers conferred by the foregoing clauses of this By-Law to such extent and in such manner as the Directors shall determine at the time of such delegation.

1.2 The foregoing borrowing is hereby authorized pursuant to Section 56(3) of the *Condominium Act, 1998*
